This location does not comply with Rule 1004. It does not appear any reclamation work has been performed since the previous inspection (doc #696105288; 07/05/2022). The location has evidence of non-uniform vegetation cover resulting in areas of bare/exposed soils and undesirable vegetation (e.g. kochia and russian thistle) was observed throughout. Additionally, the location and access roads have not been contoured and regraded to reflect pre-disturbance levels. Additional reclamation activities are required. Refer to attached inspection photos.
