## INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the SHABLE 14-23 wellhead cut and cap. The wellhead was cut and capped per ECMC rules. Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead. The flowline was previously abandoned on 11/21/2018, and the ECMC was notified on Form 44 Document number 403216829. A historical release was identified at the wellhead based on laboratory analytical results exceeding ECMC Table 915-1 protection of groundwater soil screening levels, only.

## PROPOSED SAMPLING PLAN

### Proposed Soil Sampling

Will soil samples be collected as part of this investigation? ( Number, type (grab/composite), analyses, and locations of samples ):

Five (5) grab soil samples were collected at the wellhead excavation, and soil samples were field screened at the N-E-S-W sides of the wellhead. Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

A background sample was collected from similar lithologic soil near the wellhead for EC, SAR, arsenic, barium, lead, and selenium analysis. Residual SAR, arsenic, and barium values/concentrations are consistent with/less than background comparison. Additional background samples for EC, lead, and selenium analysis will also be collected.
