CORRECTIVE ACTIONS:

Corrective Action: Comply with Rule 1004. Reseed disturbance areas using a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management.

Basis for Review: Action requested was already completed prior to the inspection

Operator Comment: See attached work request completion reports for seasonal maintenance performed in May, August, and September of 2023. Inspection doc #713900263 performed outside of warm and/or cool growing seasons. Site is routinely mowed and inter-seeded with an approved mix. Land is heavily grazed and hinders reclamation progress and timeline. OXY will continue to monitor and maintain seasonally until site has successfully achieved Rule 1004 requirements.

COGCC Decision: **Not Approved**

COGCC Representative: Based on observations in the field, though additional seeding activities within the eastern areas of the Location was apparent, Reclamation Specialist did not observe any evidence that additional reclamation work had been performed within the disturbed areas on the west end of the Location.

Additionally, documentation provided by Operator attached only shows work performed within the areas of the Location east of the access road.

No additional work will be required within the eastern disturbance where recent reclamation work is apparent; however, the corrective action requiring reclamation work will remain applicable for the western areas of the Location.

If it is determined grazing pressure is hindering reclamation as indicated by Operator, Operator shall implement mitigating measures in order to minimize or prevent grazing pressure until Location receives a passing final reclamation inspection; It is the Operator's responsibility to ensure that the Location remains in compliance and progresses towards ECMC 1004 standards.
