Operator Comment: See attached seasonal work request completion reports from May, August, and September 2023. Inspection doc #713900261 performed outside of warm and/or cool growing seasons. Site is routinely mowed and inter-seeded with an approved mix. Cereal rye establishment is a result of former cropland production in the land(s). OXY will continue to monitor and maintain seasonally until site has successfully achieved Rule 1004 requirements. Meter house which remains on former facility location is not OXY operated and will be removed and reclaimed by the associated owner accordingly.
