Corrective Action: Comply with Rule 1004. Reseed disturbance areas using a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management.

Basis for Review: Corrective action dates are not attainable

Operator Comment: Please refer to Site Reclamation Dates under the Reclamation Plan portion of F27 doc# 403543172. Well site has not been reclaimed at this time due to ongoing remediation and monitoring activities which immediately followed P&A. Observed reclamation along the western portion of the associated two-track is affiliated with separate line removal reclaim earlier in 2023, as can be seen in Photo 8 of doc# 713900251. OXY will schedule and perform final reclamation activities at the PSC 9-8 well site once weather and ground conditions are suitable to do so, likely Spring 2024.
