Stained soil: Rule 905 e Corrective action date of 2-24-24  
Mechanical issue well head: Rule 608 e Corrective action date of 1-25-24  
Mechanical issue 2" load line piping: Rule 608e Corrective action date of 2-24-24  
Weather conditions: cloudy  
I spoke with Jeff Davis about the well head leaking he said he would address in the morning.
