Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

OPERATOR COMMENT

The operator is requesting to leave pH outside of the Table 915-1 standard range, in one sample, in place based on the sample's relative depth below the root zone and additional complementary analytical background data.

pH outside the Table 915-1 standard range exists in previously and currently uncultivated rangeland. pH, observed in a single discrete location at the former tank battery, is the only constituent across all samples analyzed not in compliance with Table 915-1 standards. pH exceeding the Table 915-1 standard range was also observed in multiple background samples collected in native soils adjacent to the former tank battery. This suggests that since organic and inorganic impacts, barring pH, were not observed site wide it is likely that pH concentrations outside the Table 915-1 concentration range are related not to a petroleum release but to the chemical variability of native soil at the pH location. Therefore, the operator proposes to leave pH in place without conducting additional delineation.

	<p>Based on the information presented, it appears the elevated pH sample from the wellhead area appears to be de minimis in quantity or within the range of background pH and there is no indication of a spill; therefore, elevated pH may not be associated with E&P activities. It appears that no further remedial action is necessary at this time and the ECMC approves the closure request. However, should future conditions at the site indicate contaminant concentrations in soils exceeding ECMC standards or background levels or if groundwater is found to be impacted, then further investigation and/or remediation activities may be required.</p> <p>The surface area disturbed by the remediation activity shall be reclaimed in accordance with the 1000 Series Reclamation Rules. For locations with active ongoing oil and gas operations, comply with Rule 1003 interim reclamation requirements and for locations that will no longer have active oil and gas operations, comply with Rule 1004 Final Reclamation requirements.</p>
