Caerus will conduct groundwater sampling on a quarterly basis. Quarterly monitoring will include gauging fluid levels of all 14 groundwater monitoring wells and collecting groundwater samples from all monitoring wells in which measurable light non-aqueous phase liquid (LNAPL) is not observed. A sample will also be collected from spring sample point SC00609724BDD1. All water samples collected will be submitted for laboratory analysis of analytes listed for groundwater in COGCC Table 915-1. Groundwater monitoring and sampling activities will be reported to the COGCC quarterly via a Supplemental Form 27. Please see Figure 1 of the attached document which depicts all 14 sample points along with the abandoned monitoring well location MW-02.
