The operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management. The operator shall submit a Form 4 Final Reclamation Complete notice when the location meets Rule 1004 standards. ECMC may conduct inspections prior to receiving said notice to ensure compliance with Rule 1004.
