INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Produced Injection Water leak originating from the 10 inch Crest Line just off of the AC McLaughlin 78X well (API-05-103-0915). Leak occurred around 9-10am on 6/1/2023. Leak was isolated and contained, clean up and water washing was started. All proper notifications have been made.

Preliminary soil samples were collected from along the spill path on 7/12/2023. A total of seven (7) grab samples analyzed for Table 915-1 parameters were collected at a depth of 1 foot below ground surface. Three (3) background samples were also collected from a depth of 1 foot and analyzed for a shortened list of Table 915-1 parameters. Results indicate elevated levels of SAR, EC and HSB above background levels within the impacted area.
