	<p>This location does not comply with Rule 1004. The access road, well and tank battery location have mostly annual, weedy vegetation, which is not reflective of reference area vegetation. Also, there appears to be subsidence at the wellhead.</p> <p>There has been some land use change along a portion of the access road that is not the responsibility of the Operator. The surface owner has a fire pit that is being accessed via a portion of the access road. Operator is responsible for the red outlined area shown in Photo #4.</p>	
Corrective Action:	<p>Comply with Rule 1004. All areas compacted by drilling and subsequent oil and gas operations shall be cross-ripped to a depth of eighteen (18) inches. Reseed disturbance areas using a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management.</p>	Date <b>05/15/2024</b>
