Location is within Black Bear/High Priority/NSO Habitat areas.

Location is approximately 47 yards from Pete & Bill Creek.

While there, I observed normal production operations.

During this inspection the following compliance issues were observed:

1. Signs/Marker - Tank labels have inaccurate information/lack required information with a CA date of 03/03/2024
2. Signs/Marker - Tank battery lacks required signage with a CA date of 03/03/2024
3. Housekeeping - Unused equipment on location with a CA date of 03/03/2024
4. Equipment - Open ended load lines with a CA date of 02/09/2024

A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with CECMC rules.
