OPERATOR COMMENTS AND SUBMITTAL

Comments

The distance to the completed portion of the nearest well in the same unit on the "Spacing & Formation" tab is measured to the proposed Jesser East 3E-20-02 . This distance was measured in 2-dimensional space.

The nearest existing or proposed wellbore belonging to another operator is the Avex 11-2D, API #05-123-35223. A Stimulation Setback Consent is not required because the wellbore is plugged and abandoned. This distance was measured in 3-dimensional space.

Attached as OTHER, is the anti-collision analysis which factors in three dimensional measurements as well as gyro surveys performed on some of the offset wellbores. All measurements to offset wellbores were derived from this analysis.
