Comment:

The well location (Location ID 330118 with API# 123-18431) is within a land use change (RV and boat storage facility). Staff did not find any evidence of oil and gas activity or equipment during this inspection; the former well location has been paved over and is currently being used as a storage yard. The Operator is required to submit a Form 44 abandonment verification for off-location flowlines; doc #403293604 is currently in "draft". This location will remain "In-Process" until the Form 44 has been approved at which point ECMC Staff will reinspect at a future date.
