This location is within or in close proximity to Parks and Wildlife (CPW) District with Black Bear, High Priority, NSO, Density, and Other Consultation Habitats.

Follow up inspection in response to compliance issues observed during Insp. #702501296 on 5/10/23. Original due dates remain on unresolved Corrective Actions:

1. Random debris. (Unresolved)
2. Chemical containment open to wildlife. (Resolved)
3. Gas meter calibration not visibly displayed. (Resolved)
4. Stormwater BMPs need implementation and maintenance. (Unresolved)
