Lab results from all 3 sample events confirm that groundwater was never impacted. Maggie would like to request approval to abandon alluvial aquifer monitoring well MW-01. ECMC COA "ECMC agrees to cease groundwater monitoring of alluvial monitoring well MW-01 and ECMC agrees to abandonment of dry deep borehole." COA in approval, "ECMC agrees to cease groundwater monitoring of alluvial monitoring well MW-01."

During onsite inspection, Document #693701100, on 1/11/2024, Rick Allison noted that "ECMC Environmental Staff onsite to observe coring/drilling a portion of deep monitoring well. Driller had advanced to approximately 250 feet below ground. Rock in core at 250 foot depth appears to be fairly dense fine grained shale or marl/mudstone, dark gray in color with no sign of water present."
