INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the UPV 23-0214 wellhead cut and cap. The wellhead was cut and capped per ECMC rules. Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead. Historical soil impacts were observed, and subsequent remediation will be completed.

Pursuant to ECMC Rule 911 a site investigation will be conducted pertaining to the UPV 23-0214 flowline abandonment. Approximately 2060' of flowline will be abandoned-in-place. This flowline lies in a common trench with at least one other line. So as to not disturb the other line(s) sharing the common trench, soil samples will only be taken at the wellhead and at the endpoint of the flowline. The ECMC will be updated in a supplemental Form 27 if a portion of the flowline is able to be removed. The Flowline Pre-Abandonment Notice Document number is included under Related Forms.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

Five (5) grab soil samples were collected at the wellhead excavation for laboratory analysis. Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead. Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, EC, SAR, pH, and boron.

A grab confirmation soil sample will be collected at the flowline terminus at the separator. Soil samples will be analyzed by a certified laboratory for TPH (C6-C36), organic compounds in soil per ECMC Table 915-1, EC, SAR, pH, and boron. All samples collected were/will be analyzed by a certified laboratory using approved ECMC laboratory analysis methods.
