How was extent determined?			
Following cut and cap operations at the Fehr 26-32 wellhead location on December 12, 2023, confirmation soil samples were collected from the former wellhead and submitted for laboratory analysis of BTEX, naphthalene, 1,2,4-trimethylbenzene (TMB), 1,3,5-TMB, total petroleum hydrocarbons (TPH) - gas range organics (GRO: C6-C10), TPH - diesel range organics (DRO: C10-C28) and oil range organics (ORO: C28-C40), pH, specific conductance (EC) and sodium adsorption ratio (SAR), and boron ECMC-approved methods appropriate for detecting the target analytes. Preliminary analytical results received on January 22, 2024, indicate that the barium concentration in wellhead soil sample WH-B01-1@8' exceeded the ECMC Table 915-1 Cleanup Concentration. Assessment activities are ongoing and will be summarized in a forthcoming quarterly Form 27-Supplemental Site Investigation and Remediation Workplan under Remediation Project No. 31098 (approved Form 27 Document No. 403423363). A topographic Site Location Map showing the geographic setting of the release is provided as Figure 1. The soil sample locations are illustrated on Figures 2 and 3. Soil sample location and field screening data are provided in Table 1. Soil analytical results are summarized in Tables 2 through 5. The preliminary laboratory analytical report is provided as Attachment A. Field notes and a photographic log are provided as Attachment B. The State Notification email is provided as Attachment C.
