This Site was drilled and sampled in September 2023 to delineate inorganic impacts identified in the original excavation. Two borings were advanced near the excavation area (SB01 & SB02). Analytical results from these borings indicate that the EC impacts have been delineated. Also, additional background samples were collected in June 2023. Please see the attached Analytical Data, Table, Figure, and Boring Logs.

In addition, a produced water sample was collected in February 2023. Please see the attached Operator Knowledge Statement and Analytical data for details.

Summit plans to submit a 915b reclamation plan with the next Form 27 update.
