OPERATOR COMMENTS AND SUBMITTAL

Comments

Noble Energy shall isolate both the Fox Hills and UPIR/Pawnee Aquifers with surface casing from hydrocarbon bearing zones and exposure to oil-based drilling fluid. Noble Energy also agrees to not expose the UPIR/Pawnee Aquifers to oil-based mud.

The nearest well in the same formation is located on the same pad, the GUTTERSEN Y12-773 operated by Noble Energy INC. Measured in 2D.

The distance to another wellbore belonging to an outside operator is the BOYD 24-4H (API: 05-123-46596) Operated by VERDAD RESOURCES LLC, status TA. The distance was calculated using the anti-collision summary.

There are no wells within 150' besides the wells located on the same pad.

All wells on the pad will have a cement bond log with gamma-ray run on production casing (or on intermediate casing if production liner is run) into the surface casing. The horizontal portion of every well will be logged with a measured-while-drilling gamma-ray log. The Form 5, Completion Report, for each well on the pad will list all logs run and have those logs attached. The Form 5 for a well without open-hole logs will state "Alternative Logging Program - No open-hole logs were run" and will clearly identify the type of log and the well (by API#) in which open-hole logs were run.
