4 consecutive quarters of sampling and analysis demonstrating compliance with Table 915-1 and WQCC Regulation 41 numeric and narrative groundwater quality standards and classifications, as incorporated by reference in Rule 901.b, if applicable. The GW monitoring wells at this location have never shown any contamination. Magpie conducted an extra sample event on 4/21/23, 4 of 5 MWs sampled , MW-04 damaged. All GW results from that sample event were non-detect. Please see attached summary report." Per approval of the Form 27, "COGCC agrees to allow removal of the monitoring wells."
