A site investigation will be conducted pursuant to COGCC rule 911 at the State Antelope 41-15HZ (422729) oil and gas location pertaining to the cut/cap of the State Antelope 41-15HZ (05-123-33361), decommission of production facilities, decommission of all on-location flowlines, and decommission of off-location ANT 41-15/3/GP Line. See site map exhibit for details.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

☒ Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

Grab confirmation soil samples will be collected from beneath the above ground oil tanks, water tanks, separator, wellhead, and flowline start/end points. Potholes will be dug every 250 feet along the flowline path. These observation points will be photographed and field screened. Additional soil samples will be collected when flowline repairs are observed, changes in flow direction, or when there is a change in the flowline material type. A grab confirmation soil sample will be collected from the side wall that indicated the highest field screening levels. Soil samples will be analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected will be analyzed by a certified laboratory using approved COGCC laboratory analysis methods.
