<p>The cattle guard remains at the beginning of the access road and the fence has not been installed back to the original position. The fence at the location is not maintained and the wire gate is down and is not preventing livestock entry. The location has not established perennial desirable vegetation and there are mostly undesirable weeds that will need to be controlled and removed. The location will need to be reseeded before the upcoming growing season. Ongoing weed control such as mowing will need to be performed throughout the growing season to prevent competitive weed growth. Continue to monitor and maintain the location until the final reclamation requirements are achieved.</p>
