Comment: The fence off the county road has not been installed back to the original position. The location has not established sufficient perennial vegetation cover and there are undesirable weeds that will need to be controlled and removed. The location will need to be reseeded before the upcoming growing season. Ongoing weed control such as mowing will need to be performed throughout the growing season to prevent competitive weed growth. Continue to monitor and maintain the location until the final reclamation requirements are achieved.
