On Wednesday, 02/21/2024, Inspector Kirby Burchett, conducted a routine field inspection at Hilcorp Energy Company on the Duncan Vanschaick-612N100W 29SWNW pad, Location #333337, in Moffat County, Colorado.

This location is within or in close proximity to Parks and Wildlife (CPW) District and High Priority Habitat area with NSO, Density, and Other Consultation Habitat regulations.

Any Corrective Actions from previous Inspections are still applicable.

While there during normal production operations the following compliance issues were observed:

1. Debris.
2. Oily waste.
3. Tank labels incomplete.
4. No tank battery sign.
5. Unused equipment.
6. Open end load line.
7. Equipment open to wildlife.
8. Gas meter calibration out of date.
9. Production Reports not up to date.
