Filled hole with sand to 4785'. Dumped 5 sacks of cement, 4785-4737'. Worked 4 1/2" casing to 12" tension. Shot casing loose at 1801'. Pulled 61 jts. Filled hole with mud, 4737-122'; dumped 10 sacks of cement, 122-87'; mud, 87-21'; 5 sacks of cement, 21' to base of cellar and welded plate on top of casing. Plugged in August, 1966.
