Comment:	Complaint is regarding pre-emergent herbicide sprayed on location and onto tumbleweed debris that blew off site into the pasture. On the day of this inspection, there was high wind conditions. There was tumbleweed debris observed along the tank battery fence. There was weed debris observed inside the tank battery fence which had blue die from herbicide application. The tumbleweed debris can be transported off site from wind conditions with a concern of translocating the herbicide with the debris. The weed debris will need to be removed and properly disposed. Avoidance of spraying tumble weed debris shall be taken to avoid potential drift and translocation off-site.
