Summit DJ-S LLC acquired this and other assets in December 2022. However, Summit DJ-S did not obtain an operator number until January 2024. Therefore, this form was originally submitted via email to Krystal Heibel on August 25, 2023. Please see attached for the original form.

Summit DJ-S (Summit) excavated and sampled this spill in June through August 2023. Please see attached for confirmation sample analytical data. Analytical results indicate that exceedances in EC, SAR, Arsenic, and Boron still exist. All pH exceedances were below the locally collected background samples. In addition, Summit potholed and sampled for inorganic delineation purposes in August 2023.
