Summit DJ-S (Summit) excavated and sampled this spill in June and July 2023. Please see attached for confirmation sample analytical data. Analytical results indicate that exceedances in SAR, Arsenic, and Boron still exist. All pH exceedances were below the locally collected background samples. In addition, Summit potholed and sampled for inorganic delineation purposes in August 2023. Summit is currently awaiting the analytical results from this event.
