INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

On June 27, 2023, Initial Form 27 Document 403422137 was submitted as notification to remove the partially buried vessel (PBV) and to open Remediation Project 30164.

On October 26, 2023, initial sampling was conducted to characterize the excavation following the removal of the PBV. Five soil samples were collected: one from the base of the excavation at 6 feet below ground surface (bgs), and one from each sidewall at 4 feet bgs. Analytical results of excavation soil samples indicated compliance with Table 915-1 Residential Soil Screening Levels (RSSLs) except for pH, arsenic, and hexavalent chromium. One pH exceedance at the west sidewall was detected at 8.74. Arsenic exceedances were detected in all samples with concentrations ranging from 4.59 milligrams per kilogram (mg/kg) to 9.22 mg/kg. Hexavalent chromium exceedances were detected at 0.351 mg/kg and 0.610 mg/kg at the north and south sidewalls, respectively.

As part of the investigation, produced water tank samples obtained from the nearby Mesa 2 (ECMC Location ID 334633), Mesa 17 (ECMC Location ID 335527), and Starkey 7 (ECMC Location ID 335092) well pads were referenced for source characterization. The Mesa 2 well pad is located 1.7 miles southeast, Mesa 17 is located 2.6 miles north, and Starkey 7 is located 1.2 miles northeast. All wells produce from the same formation (Williams Fork-Cameo) as the Location. Analytical results indicate pH values ranging from 6.70 to 6.99 and did not detect arsenic above the laboratory Reporting Detection Limit (RDL) for all samples. Although pH and arsenic levels exceeding Table 915-1 RSSLs are present in the investigation area, analytical results of the produced water characterization samples indicate near-neutral pH values ranging from 6.70 to 6.99 and did not detect arsenic above the laboratory Reporting Detection Limit (RDL). Considering the common production zone and consistent analytical data derived from the Williams-Fork Cameo formation, it is reasonable to conclude the produced water samples are representative of source characterization for the Location. Therefore, Caerus requests consideration of Rule 915.e.(2).C to remove pH and arsenic as constituents of concern.

Although hexavalent chromium concentrations exceeding Table 915-1 RSSLs are present in the investigation area, they are below the laboratory RDL, or Practical Quantitation Limit (PQL), of 1.0 mg/kg. Consequently, Caerus requests to use ECMC Table 915-1 Footnote 9 to substitute the RDL of 1.0 mg/kg as an alternative screening level for hexavalent chromium.

Assuming the proposed requests are approved, all constituents of concern are compliant with Table 915-1 RSSLs or within the requested alternative allowable limits. Based on this information, no further investigation appears to be warranted and Caerus request a no further action (NFA) determination for Remediation Project 30164.
