ECMC Inspection Report Summary

On Wednesday, 03/06/2024, Inspector Kirby Burchett, conducted a follow up field inspection at KT Resources LLC on the WRD Federal 21 -33 well, Location #316256, in Rio Blanco County, Colorado.

This location is within or in close proximity to a Parks and Wildlife (CPW) District, Black Bear area with High Priority, NSO, Density and Other Consultation Habitat regulations.  
Any Corrective Actions from previous Inspections are still applicable.

Follow up inspection in response to compliance issues observed during Insp. #702501133 on 4/11/23. The following Corrective Actions were issued and original due dates will remain on any unresolved CA's:

1. Stormwater BMPs not implemented or maintained. (Unresolved)
2. Gas meter calibration card not conspicuously posted. (Resolved)
3. API Number missing on tank battery sign. (Resolved)
4. Chemical tank labels illegible or missing. (Resolved)
5. Chemical containment full of liquid waste. (Resolved)
6. Chemical containment wildlife netting not maintained. (Resolved)
7. Thief hatch open on production tank. (Resolved)
8. Tank battery containment corners leaking. (Unresolved)
9. Open conductor around wellhead. (Resolved)
10. Chemical tank not in use. (Resolved)
