No Base sample was taken due to the presence of groundwater or at the South sidewall as this wall has so far been found to be clean and no further excavation in that direction is planned. However, further excavation is planned in the East and West directions due to elevated PID readings in those directions. PID readings were the following North - 1.0, East - 430.8, West - 321.8.		
The current excavation is approximately 12ft long x 10ft wide x 9ft deep and is surrounded by orange construction fencing.		
Excavation is approximately 30-40ft NE of nearest domestic residence.
