Dear Mr. Lee:

Ensolum, LLC (Ensolum) is contracted by Kerr McGee Oil & Gas Onshore LP (Kerr-McGee) to complete final reclamation inspections at plugged and abandoned (P&A) well sites located in Weld County, Colorado. The reclamation inspections were conducted in accordance with Colorado Energy & Carbon Management Commission (ECMC) Rule 1004.

The former Lind 9-6 well (API: 05-123-25706) was P&A'd on December 04, 2023, as identified in Form 6, Document Number 403642091. On March 1, 2024, Ensolum conducted a final reclamation inspection for the former Lind 9-6 well pad and it was determined that the site is compliant with final reclamation requirements per ECMC Rule 1004. The former Lind 9-6 well is located on an active pad (Location ID: 333159). The associated tank battery remains active and is located 0.15-miles southeast of the P&A'd well. The former Lind 9-6 tank battery remains in use servicing Kerr-McGee producing wells: API: 05-123-29556; API: 05-123-25708; API: 05-123-25707; and API: 05-123-25709. Ensolum personnel located the P&A'd wellhead location using a handheld Trimble DA2 Global Positioning System (GPS) unit and latitude and longitude coordinates obtained from the ECMC online database. A general site location map is included as Figure 1; and the Site Map displaying the location of the reclaimed site on aerial imagery is included as Figure 2. Photographs of the P&A location were taken facing each cardinal direction from the P&A wellhead location. The photographic log is included as Attachment 1.

Based on rule 1004.d, the Lind 9-6 has been compacted and stabilized with roadbase on an active facility, a Form 4 Sundry Notice requesting final reclamation status has been prepared for the submittal to the ECMC. This letter will be included as an attachment to the electronic Form 4 submittal.

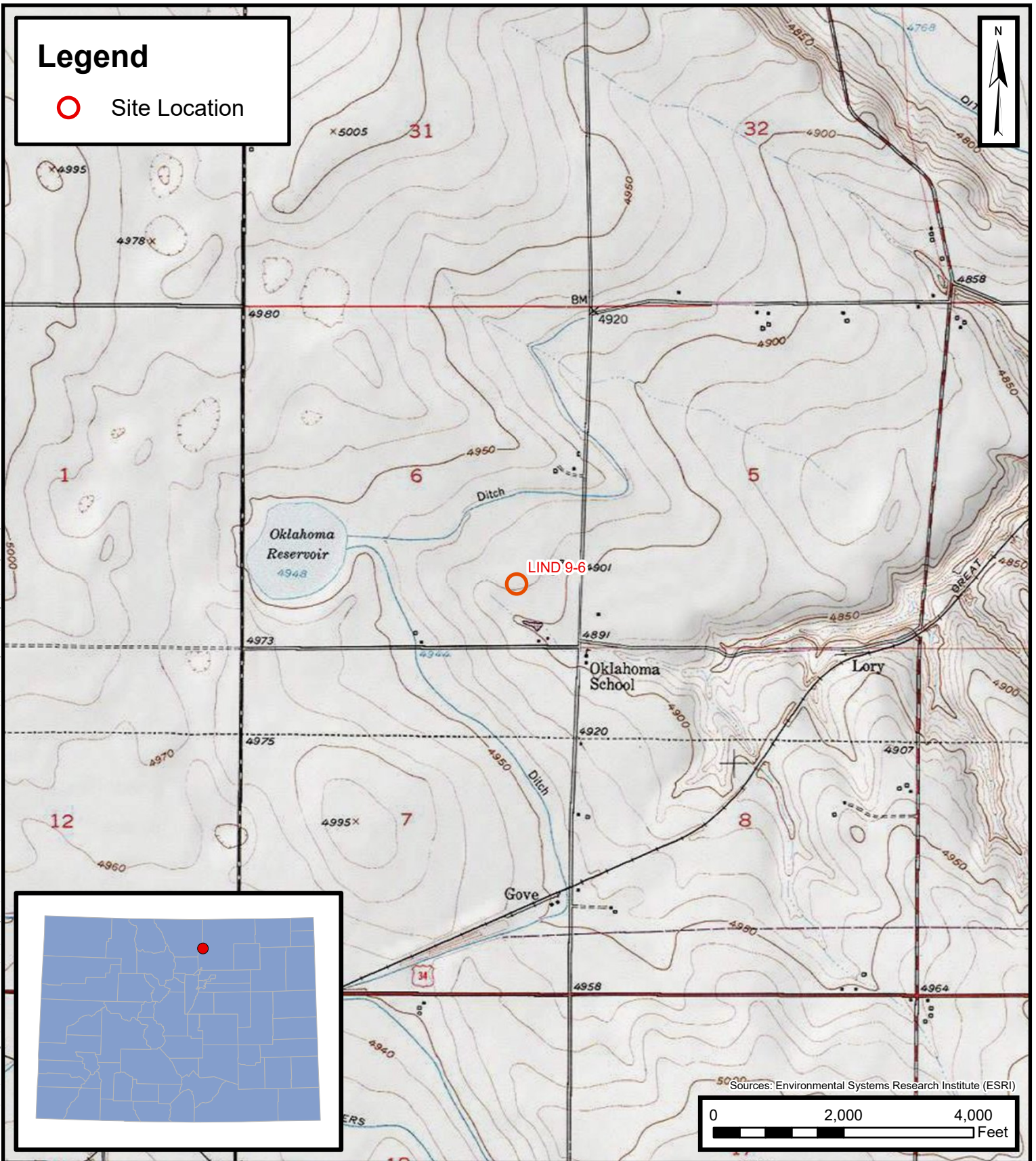

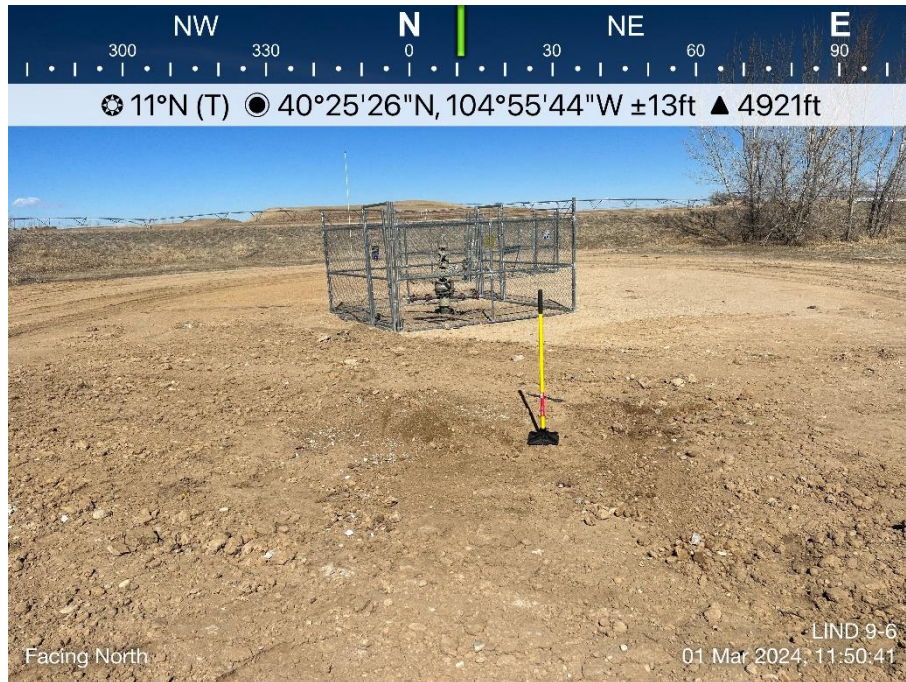

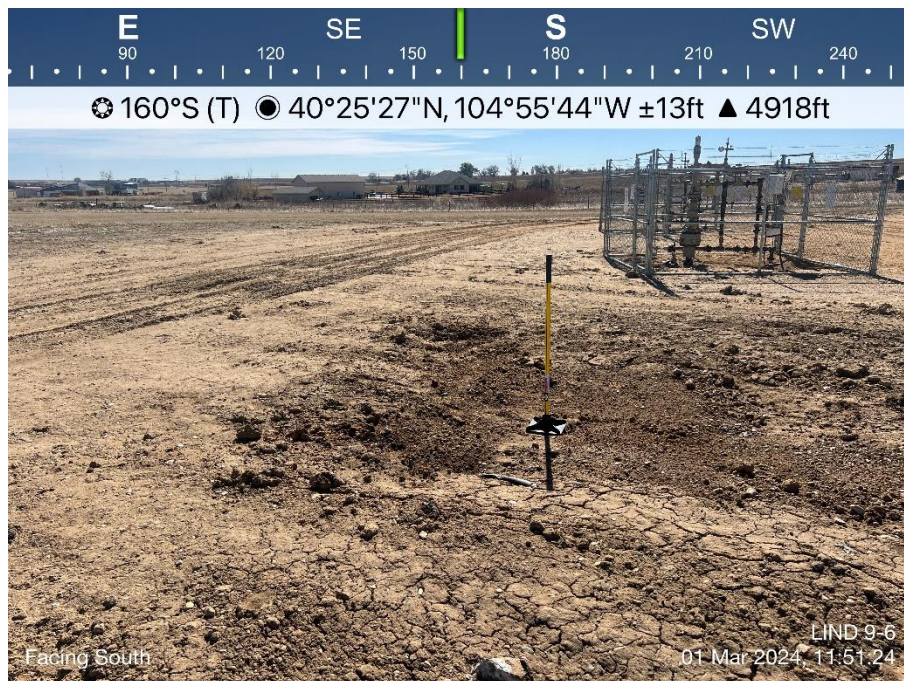

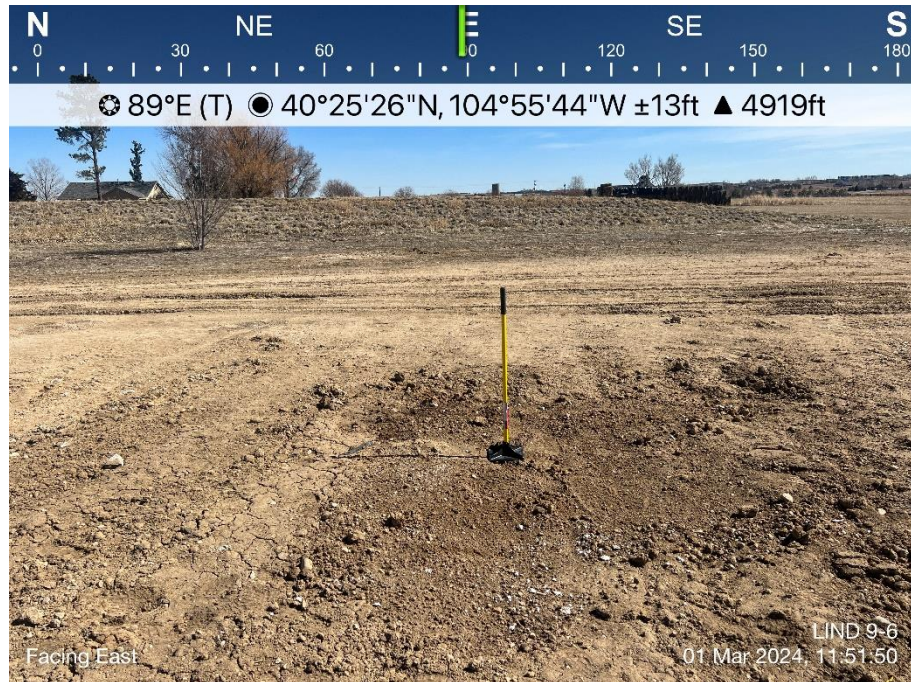
