Twenty five (25) grab confirmation soil samples were collected from the produced water vessel(s) excavation, beneath the ground oil tanks, and at the separator risers. Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, metals, EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved COGCC laboratory analysis methods.
