A compromised fitting inside the separator cabinet resulted in 3 bbls of produced water to spill to the ground surface. The impacted soil will be removed and hauled for disposal. Confirmation soil samples will be collected and submitted in compliance with ECMC Table 915 -1. In addition, a waste characterization sample was collected and submitted for Table 915 analysis. Analytical results will be submitted on a supplemental form.

OPERATOR COMMENTS:

During the initial spill assessment a waste characterization sample and background sample was collected. TPH and the majority of 915 organics were Non-Detect, however, Benzo(a)Pyrene was elevated at 0.00573 mg/kg. Elevated levels of SAR (26.6) was also observed and elevated levels of Arsenic and Barium were observed, however, were below 1.25* the background Arsenic and Barium levels. Based on the attached analytical results, Extraction requests to amend the sampling and analysis plan to TPH (C6-C36), Organics, and SAR.
