Final reclamation areas are not progressing towards 1004 revegetation standards. Perform reclamation per Rule 1004. Reseeding of native vegetation appears to be needed to meet total perennial, non-invasive uniform plant cover of at least 80 percent of reference area levels. Use surface owner seed mixture, coordinate with surface owner to acquire required mixture. Ensure erosion controls are implemented to stabilize the reseeded soil, and continue to monitor and manage the site. Weeds should be controlled in order to not impede the perennial vegetation establishment. See good housekeeping.
