To Whom It May Concern:

Kerr-McGee Oil & Gas Onshore LP is applying for a permit to drill for the captioned horizontal wells below. Pursuant to Rule 408.t, you are being provided notice of a proposed wellbore lying within one hundred fifty (150) feet of the existing active wells cited below. Additionally, pursuant to Rule 408.u, no portion of a proposed wellbore's treated interval shall be located within one hundred fifty (150) feet of an existing (producing, shut-in, or temporarily abandoned) or permitted oil and gas wellbore's treated interval belonging to another operator without the signed written consent of the operator of the encroached upon wellbore.
