Summit DJ-S LLC acquired this and other assets in December 2022. However, Summit DJ-S did not obtain an operator number until January 2024. Therefore, this form was originally submitted via email to Krystal Heibel on October 27, 2023. Please see attached for the original form.

Summit DJ-S (Summit) excavated and sampled this spill in August 2023. Please see attached for confirmation sample analytical data. Analytical results indicate that exceedances in EC, SAR, Arsenic, and pH still exist.

Summit plans to re-excavate to remove these exceedances in Q4 2023 or Q1 2024.
