INSTRUCTIONS

Notice must be given to the Director, and approval obtained in advance of the time when the owner or operator expects to recomplete or abandon a well or to change plans. Within thirty (30) days after recompletion, change of plans, or remedial work, a detailed report of the work done and the results obtained shall be submitted on this form in duplicate for wells on Patented and Federal lands, and in triplicate for wells on State lands. In work that affects only rods, pumps or tubing or other routine work such as, but not limited to, cleaning out to previous total depth, no report is necessary.

(DETAILS OF WORK)

Pan American drilled subject well to a total depth of 4950. Plugged back depth is 4538.

Uneconomical to produce well because commercial quantities of oil and/or gas cannot be produced.

Proposed 4-1/2" casing recovery program:

1. Determine free point with free point indicator.
2. Place 16 sacks of cement in bottom of 4-1/2" casing.
3. Shoot off casing and recover the maximum amount obtainable.

Proposed Plugging Program:

1. Place five sacks of cement at the surface casing shoe at 203 ft. RDB.
2. Cement top of surface casing with 10 sacks of cement.
3. Install permanent marker consisting of a piece of pipe not less than four inches in diameter of which 4 ft. will be above ground level and 6 ft. imbedded in cement in the surface casing.
4. The location will be leveled and restored to its original contours.
