

MEMO

SUBJECT: Field Trip - McClave Field and Southeastern Colorado - July 23-26, 1963

An inspection trip was made to the McClave Field during the period of July 23 - 26, where testing of the gas wells was in progress.

The tests were being conducted by Thurmond-McClothlin of Pampa, Texas, (Jack Chisum, field engineer). Each well has been equipped with a permanent set-up of a Rotary Positive Displacement type gas meter (Emcorector Type I). Due to avoidance of interruption of gas deliverability from the field, a few wells were put on test at one time. The wells were allowed to stabilize their flow from 20 - 24 hours prior to the test. There are separate gas meters on those wells that are dually completed. A close check was being maintained on tubing and casing pressures during the test. The testing commenced July 22 and is expected to take approximately 20 days to complete. A report is to be submitted to this office regarding the results, as well as G. P. M. analysis of the gas.

A gas plant is located in the southern portion of the field (Sec. 26, 20S-48W). The plant was built by the Bering Corp. of Dallas, Texas, but is being operated by Fleetwood Drilling Co. It is a small plant, and there is no permanent personnel. Periodic checks are made by a contract worker (Howard Johnson, Wiley, Colo., a nearby town on Highway 287). I was unable to contact anyone to find out more definite information, such as capacity, etc.

A visit was made to the No. 2 Hoff Heirs well, located in the SW NE, 35-29S-60W, Model Dome Field, Las Animas County. Only this one well was drilled by the operator, Robert E. Thorpe. A rancher, A. C. Morris, who lives in the area, was familiar with the operations. However, he does not know the present whereabouts of Thorpe, and had always thought he had a Denver office. The well is shut in, and a check of the files shows that all forms required are in. I was also informed by Morris that at least 2 or 3 wells were drilled during the past year in an area north of Thatcher, Colorado. No one seems to know who the operators were. The wells were quickly drilled and plugged.
