While there, I observed that the wellhead sign lacked an emergency contact number and there was unused equipment on location. During this inspection the following possible compliance issues were observed: Rule 605.d. with a corrective action date of 4/19/2024, Rule 606. with a corrective action date of 4/19/2024. A follow up inspection on this site needs to be conducted to ensure the compliance issues have been corrected to comply with ECMC rules.
