Please refer to inspection 708900858 conducted on 06/26/2023, previous corrective actions have been completed. Location is within High Priority/Density/Black Bear Habitat areas. While there, I observed normal production operations.

During this inspection the following compliance issues were observed:

- Housekeeping - Wellhead cellar cover not properly installed/wildlife & personnel hazard with a CA date of 03/25/2024
- Equipment - PRV vent lines for tank burners do not comply with CECMC pressure safety device rules & also terminate in an unsafe manner with a CA date of 03/25/2024

A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with CECMC rules.
