**INITIAL ACTION SUMMARY**

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the WATKINS 13-05 wellhead cut and cap and flowline removal. The flowline was partially buried in place due to field constraints and a Form 44 document # will be provided on a subsequent supplemental Form 27. The wellhead will be cut and capped per ECMC rules. Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead. Soil samples were taken along the flowline at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. The Flowline Pre-Abandonment Notice Document number is included under Related Forms.

**PROPOSED SAMPLING PLAN****Proposed Soil Sampling**

A grab soil sample will be collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. Additionally, soil samples will be field screened at the N-E-S-W sides of the wellhead. Soil samples will be taken along the flowline at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. Soil samples will be analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected will be analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

**OPERATOR COMMENT**

Three background soil samples were collected from two discrete locations within native soil adjacent to the site. The average pH and SAR concentrations in decommissioning soil samples were 8.20 and 3.95, respectively. The average pH and SAR concentrations in background soil samples were 8.31 and 4.76, respectively. Since the pH and SAR concentrations observed in background soil samples were higher than the pH and SAR concentrations observed in the decommissioning soil samples, pH and SAR should not be considered contaminants of concern at the Site.
