Corrective Action	With the discovery of deceased migratory birds in the open topped tank that had no BMPs to protect the wildlife, Strachan is now required to remove the fluids from the tank to ensure that no endangered, threatened or additional migratory bird species have died in the E&P waste. ECMC Staff Ryan Costa must be notified via a Form 42 Notice of Other no less than 72 hours before the tank the fluid is removed so ECMC staff, and possibly other regulatory agencies, can observe the removal of the fluids to determine whether additional wildlife is present in the fluids and that proper disposal of the E&P waste is conducted.
