On Tuesday, 03/19/2024, Inspector Kirby Burchett, conducted a routine field inspection at KT Resources LLC on the Ant Hill Unit 8-12 well, Location #316629, in Rio Blanco County, Colorado.

This location is within or in close proximity to a Parks and Wildlife (CPW) District, Black Bear and High Priority area with NSO, Density and Other Consultation Habitat regulations.

Any Corrective Actions from previous Inspections are still applicable.

While there during normal operations the following compliance issues were observed:

1. Relief riser missing rain protection.
2. Gas meter calibration out of compliance.
3. Stormwater BMP's need implementation and maintenance.
4. Well is overdue for Mechanical Integrity Test (MIT).

A follow up on this site inspection will be conducted to ensure all compliance issues have been corrected to comply with ECMC rules.
