Comment:

The access road and location have not been recontoured and reclaimed per 1004 Rules. There is gravel that remains along the access road and at the location. The location is fenced however the fence is in disrepair. There are tall undesirable weeds throughout areas of the location. All gravel and debris will need to be removed. The access road and location will need to be recontoured to the original approximate contours. Soils will need to be decompacted by crossripping to at least 18 inches. Disturbed soils will need to be stabilized to prevent erosion until perennial vegetation is established. Corrective action will remain out of compliance until completed.
