During this inspeciton, it was observed that eroison degradation (riling) was occurring north of the tank battery and on the northwest portion of the production pad. Stormwater control measures/BMPs identified in the inspection photos require maintenance. Additionally, the access road/location entrance requires maintenance as it is beginning to rut and collect stormwater.
