INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

In accordance with COGCC Rule 911, this form serves as notification for the decommissioning and abandonment of the Kallsen 14-10X production facility including production tanks, heater treater, and pumping unit. Soils surrounding and beneath production equipment will be visually inspected during decommissioning activities and confirmation soil sampling will be conducted to assess potential hydrocarbon impacts. The well (Facility ID #201669) was plugged and abandoned in December of 2023.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

Soil samples will be collected from the areas most likely to have been impacted during the operational life of the facility. These areas include but are not limited to wellheads, tanks, separators, treaters, flowlines, and pits. Background samples obtained from similar depths and soil horizons or lithologic materials for comparison to confirmation soil samples will be collected as part of this investigation. In addition, areas visibly impacted by hydrocarbons will be sampled. All samples will be submitted to a NELAP-accredited laboratory for the full Table 915-1 analysis. A proposed soil sample location map is included as an attachment to this report. Based on the depth to groundwater indicated by the nearest permitted well, Providence Operating is requesting the use of residential soil screening levels.
