INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to COGCC Rule 911 a site investigation was conducted pertaining to the SPIKE STATE CC30-13 wellhead cut and cap and flowline removal. Approximately 80' of flowline was abandoned in place due to a DCP Midstream line crossing, and 2,738' of flowline was removed. The wellhead was cut and capped per COGCC rules. Additionally, soil samples were collected at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway, AS APPLICABLE to abandonment type. The Flowline Pre-Abandonment Notice Document number was included under Related Forms on the initial Form 27.

One (1) grab soil sample was collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. Additionally, twelve (12) soil samples were collected from the bellholes opened during the flowline removal and abandonment. Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, and boron. Additionally, one (1) soil sample was analyzed by a certified laboratory for metals in soil per COGCC Table 915-1. All samples collected were analyzed by a certified laboratory using approved COGCC laboratory analysis methods.

Field personnel field screened all disturbed areas using visual and olfactory senses to determine if laboratory confirmation sampling is required. The COGCC Flowline Closure and Wellhead Closure Checklists were utilized and filled out during the abandonment process. A photolog was submitted on the Subsequent Form 27.

The source identified at FL01-I@3' and FL01-T@3' will be removed through a remedial excavation. The remedial excavation will be scheduled prior to July 31, 2024. Remedial excavation confirmatory soil samples will be collected for ECMC Table 915-1 organic compounds in soil and TPH C6-36, and compared to ECMC Table 915-1 Residential Soil Screening Levels based on the approval granted under ECMC Document Number 403519662.

Based on the previous approval to apply ECMC Table 915-1 RSSLs (refer to ECMC document number 403519662) and lack of a pathway for contaminant migration to groundwater, the fully delineated impacts identified at FL01-H@3', FL01-O@3', FL01-P@2.5', and FL01-R@3' in place.
