A site investigation will be conducted pursuant to COGCC rule 911 at the HSR-MARRS-66S62W 10NENW (322207) oil and gas location pertaining to the cut/cap of the HSR-MARRS 3-10 (05-039-06626), decommission of production facilities and abandonment of all on-location flowlines. #### Proposed Soil Sampling

Grab confirmation soil samples will be collected from beneath the above ground oil tank, water vault, separator, wellhead and flowline start/end points. A grab confirmation soil sample will be collected from beneath the produced water vault as well as from the side wall that indicated the highest field screening levels. Soil samples will be analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, and boron. All samples collected will be analyzed by a certified laboratory using approved COGCC laboratory analysis methods.
